5. Describe your organization's role in the Earth science community

OPeNDAP is involved in both research and development of systems to access scientific data. We are members of the OGC and regularly attend various meetings such as the NOAA EDM, ESIP meetings, AGU and EGU.

OPeNDAP is one half of the research group at The University of Rhode Island that developed the Distributed Oceanographic Data System (DODS). That group was one of the initial ESIP members.

6. Please describe your organization's Earth science data/technology activities.

OPeNDAP has developed the Data Access Protocol, a SOA protocol for data and metadata access that leverages the existing web infrastructure. We have also developed a data server that implements this protocol, client applications and application development toolkits that support it. In addition we have developed implementations of several of the OGC's specifications.

7. What are the primary sources of your funding?

Our primary sources of funding are grants from NSF, NASA, NOAA, and Other governments. However, we have been shifting some of our funding to contracts, both as support service providers and contract developers.

8. Describe current or anticipated users of your products and services and how you think the Federation can help you better serve this population.

Data providers use our software to make data accessible to others. Developers use our software to build dients and our specification to develop compatible software. We also distribute some end-user client software.

9. Describe technologies that you have developed and are willing to share with the Federation?

We have shared the DAP2 technology with the federation and plan to do the same with the DAP4 technology.

10. Describe how you can contribute to the efforts of one or more standing committees, working groups and/or clusters? (200 words or less)

We have participated in a number of ESIP activities, most recently we contributed one 'DCP' to the discovery working group. We have also run sessions at the last two ESIP meetings.

In general, we do not use Earth Science data, except to test our software and protocols.
